I voluntarily assume the risk, for my child, of all dangerous conditions associated with participating in Faith Lutheran Church youth activities and waive any and all specific notice of existence of such conditions.

In addition, I promise not to assert against the aforementioned parties any claim or claims that I now have or may have in the future, known or unknown, based on any injury to my minor child, my person or property as a result of participating in activities.

I **DO/DO NOT** (circle one) _____ (parent initials) authorize Faith Lutheran Church staff or volunteer to authorize any medical or dental treatment for my child, in my absence. I understand I shall be liable and agree to pay all cost and expenses incurred in relation to such medical and/or dental services to the aforementioned child pursuant to this authorization.
